III. Narrative Description of Conference

The communication of religion—its values, theology, identity, and its intersection with other life spheres (including political and social institutions) is situated in the middle of a dynamic change. Scholars are only now beginning to reframe religion as a factor whose influence is conditional (and even dependent) on processes that faith was previously thought to influence. For scholars of religion and politics, the breakthrough insights of the last decade of social science research are that religion is a malleable factor in human behavior, and one whose influence varies contextually. The proposed conference for Taft Research Center funding advances understanding of these two insights by highlighting for UC and the wider public the recent work performed by a group of scholars with UC affiliations or other linkages.

The one day conference is expected to produce three main outcomes. First, celebrate and publicize the forthcoming (2020) edited volume from University of Michigan Press—*Exploring the Public Effects of Religious Communication on Politics*, which is edited by UC's Brian Calfano, and features work by several UC faculty/graduate students who study religion and politics (e.g., Laura Jenkins, Kimberly Conger, Rina Williams, and Alexis Straka) as well as other well-known subfield scholars. As part of fulfilling this outcome, we look to feature the work of two graduate students working on projects related to religious community. Straka is completing her dissertation on the communication strategies of Muslim political candidates in the United States and Shayla Olson of Michigan State University is embarking on her dissertation data collection on white evangelicals and racial attitudes. Both will make presentations at the conference.

The conference's second outcome is to enable discussion among the scholars and other interested observers in attendance about 1) the role of religion and religious communication in the 2020 general election, and 2) the development of research projects relating to religious communication in both domestic and international political

contexts. Concerning the 2020 election, we have enlisted the participation of University of Pennsylvania political scientist Michelle Margolis, Michigan State University political scientists Nazita Lajevardi and Shayla Olson, and University of Delaware political scientist Kassra Oskooii to provide their insights. Calfano will lead a group discussion about the development of research projects.

The conference's third outcome is to provide a platform to recognize the scholarly contributions of Professor Paul Djupe of Denison University. Dr. Djupe has served as a major collaborator and editor for several UC faculty studying religion and politics, and is a contributor to the University of Michigan volume on religious communication. We have enlisted Dr. Djupe to provide a Taft Talk in conjunction with the conference.

The proposed conference will appeal to a wide array of audiences, from the general public, to specialists in religion and politics, to generalists in political science, sociology, communication, journalism, WGSS, history, and Judaic Studies—in all, at least six Taft departments will find interest in the conference subject matter. We estimate the average number of audience members to be 35-50 throughout the conference. Conference publicity will be generated through on-campus posters, list serve emails, word of mouth invites, and social media ads.
